

OFFICERS FOR MANAGEMENT.—The business of the Association shall be conducted by a Committee of twenty-one, a Chairman, Secretary, Under Secretary, and Treasurer. Treasurer and Secretary to remain in office six months. It shall be incumbent on them to attend every business night of meeting, and keep minutes of the proceedings, and perform those duties which the Association may from time to time require of them. The Treasurer shall make all purchases, and pay all bills, by a specific order of the Committee, and not otherwise, and make up a balance sheet of receipts and expenditure every quarter, for the use of the Association. Should any of them be ill and unable to attend, they shall send a written statement to that effect to the Association. The twenty-one on the first Committee shall continue in office for three months; at the expiration of that period, the ten lowest on the list shall vacate their seats, and ten others shall be elected in their stead. At the end of every subsequent quarter the ten longest on the list shall retire, whose places shall be filled up by a new election, agreeable to the Rule for the election of Officers. The retiring members may be re-elected. Seven of the Committee shall form a quorum.

ELECTION OF OFFICERS.—A fortnight previous to the quarterly meeting, which shall be held on the 3d Wednesday of August, November, February, and May, the Secretary shall make out lists of the candidates for office, from a book kept for that purpose. And the Secretary shall put the above lists in a conspicuous part of the place of meeting, and also state in them the time of election. When they are assembled for that purpose, each member shall silently deposit the names of those he wishes to be chosen in a box upon the table. Two Scrutineers shall then be chosen, by a show of hands, who shall examine the lists and declare the names of the persons elected, who shall commence their duties the following week.

EXCLUSION OF MEMBERS.—On the requisition of twenty members, who consider the conduct or character of any member inimical to the objects of this Association, a general meeting of Committee shall be called, when all the circumstances connected with such conduct or character shall be investigated; after which, they shall determine, at once (by ballot), whether such person shall be excluded from the Association or not.

VISITORS.—Each member may invite a friend (by ticket) to any meeting except those devoted to the business of the Association. He may also be allowed to address the meeting, with leave of the Chairman.

MEETINGS OF THE ASSOCIATION.—The Association shall meet on the Wednesday preceding the general meeting, for election of officers, and shall have a general meeting every Monday, at eight o'clock, for the admission of members, and for conducting the general business of the Association. They shall also hold a public meeting on any great occasion, when they conceive the interests of working men can be promoted; but on no occasion for party purposes or private considerations of individuals. They shall have a discussion on some important subject once a month.
