

## Information for Authors

### Main Articles, Features and Book Reviews

All articles, features and reviews should be sent as email attachments to [eitn@abdn.ac.uk](mailto:eitn@abdn.ac.uk) unless otherwise stated in the call for papers.

Education in the North is an open access journal listed as such by SHERPA/ROMEO <http://www.sherpa.ac.uk/romeo> and we encourage the dissemination of quality research. Authors are given permission to archive pre and post-prints as well as the final published version of their article. We ask that any use of the final published article clearly references the journal including issue number and URL. Further detail available at [Open Access Policies](#)

All contributions (including, where relevant, abstract, quotations, tabular material, references, etc.) should be presented in English or Gaelic (other languages will be considered please contact us). Each contribution should bear a title, authors' names, including corresponding author, institutions/affiliation and email addresses and should be typed on a separate sheet and submitted with the manuscript.

### JOURNAL ARTICLES

Manuscripts for the Article Section should not exceed 8000 words, although in exceptional circumstances longer articles may be considered.

Submissions for consideration should be sent as an email attachment to [eitn@abdn.ac.uk](mailto:eitn@abdn.ac.uk) for the attention of the Editors Helen Martin and Claire Molloy.

Manuscripts submitted should be original, not under review by any other publication and not published elsewhere.\* Please use minimal formatting and provide materials as Word files using Arial point size 11.

*\*Working papers and other pre-prints not under consideration by other publications may be submitted.*

To allow peer review of journal articles, all submissions must be properly formatted for anonymous reviewing:

- A separate 'title' page with title, authors' names, including corresponding author, institutions/affiliation, ORCID ID (where available) and email addresses.
- Each anonymised article should include an abstract of up to 200 words, and **five keywords which describe the content, methodological approaches and distinctive findings of the research**. These keywords will be used to support online searches so it is important that they represent your article as comprehensively as possible. All tables and figures should also be included within the article.

All pages should be numbered top right.

Footnotes to the text should be avoided.

Sponsorship of research reported (e.g. by research councils, government departments and agencies, etc.) should be declared.

The use of abbreviations or using initials for the names of organisations (unless the full name and abbreviation is given on first appearance in the text) should be avoided. Jargon or unnecessary technical language should be avoided.

Do not use '&' as the word 'and' should be used at all times.

### **Images, tables and figures**

Images, tables and figures should be presented within the article itself, clearly labelled with a short descriptive title.

Video and other types of file can also be accepted and this should be discussed with the Editors prior to submission.

### **References**

References in the text should follow the Harvard British system (author's name and year of publication, or year of publication only if the author's name is part of the text). References should be listed alphabetically at the end of the paper in the following style:

For journal papers:

AUTHOR'S SURNAME, INITIALS. and further authors if appropriate, (Year of publication). Title of article. *Name of Journal (in italics)*, **volume number (in bold)**(part or issue number), page numbers preceded with pp.

For books:

AUTHOR'S SURNAME, INITIALS., (Year of publication). *Title of book (in italics)*. Edition, if not the first. Place of publication: Publisher.

For multi-authored papers or books, names of all authors must appear in the list of References/Bibliography. In the text, however, for three to five authors, cite all authors at first citation and for subsequent citations the first author + *et al.* (in italics). For more than five authors use the first author + *et al.* throughout. Do not use **&**, as **and** should be used at all times.

Edited book chapters should include the relevant page numbers:

AUTHOR'S SURNAME, INITIALS., (Year of publication). Title of Chapter. In: INITIALS, AUTHOR'S SURNAME and INITIALS, AUTHOR'S SURNAME, ed. or eds. if an editor or editors, *Title of book (in italics)*. Edition, if not the first. Place of publication: Publisher. Page numbers preceded by pp.

Please check carefully that all references in the text are included in the list of References at the end.

## FEATURE ARTICLES

Contributions to the Features Section are generally written in a less formal style and should not exceed 4,000 words. **They require a brief synopsis of 100 words and five keywords which describe the content.** These keywords will be used to support online searches so it is important that they represent your article as comprehensively as possible

'Academic' style references do not have to be used. If they are included please follow the style details under the 'references' section above.

Avoid the use of abbreviations or using initials for the names of organisations (unless the full name and abbreviation is given on first appearance in the text). Jargon or unnecessary technical language should be avoided.

Please use minimal formatting and provide materials as Word files using Arial point size 11. If you wish to include images, video or other files please discuss with the editors prior to submission.

Feature articles are reviewed by the Editorial Board.

Each contribution should include a separate 'title' page with a title, authors' names, including corresponding author, institutions/affiliation, ORCID ID (where available) and email addresses, alongside the anonymised feature.

## BOOK REVIEWS

The journal are willing to consider books for review and reviews themselves. Please use minimal formatting and provide materials as Word files using Arial point size 11. 'Academic' style references do not have to be used. If they are included please follow the style details under the 'references' section above.

Book Reviews are reviewed by the Book Review Editor and the Editorial Board.
