



#### Open Research

- Internet has changed the way researchers work
- Research can be shared rapidly online
- Data can be shared with software to process it
- Open licences set standard terms of reuse for all research outputs
- Sharing research openly increases impact and engagement
- Benefits society on a global scale




#### When You Publish an Article

- When you write an article you automatically own copyright
- When you publish in a subscription-based journal the publisher typically asks for exclusive rights to an article
- Author hands over all their rights with certain rights handed back
- The publisher can reuse and sell the research however they wish
  - Including to the library who pays to subscribe
- Author must request permission from the publisher to share or re-use your own research
  - Can't make open in a repository until after embargo
  - Can't share on social networks
  - Can't translate etc. etc.

## Rights Retention

- There is a way to rebalance the distribution of power
  - Rights Retention
- Retain key rights to your research
- Share your peer-reviewed, unformatted accepted manuscript
  - Deposit in Pure/AURA
- Under an open licence
- Publish where you want to
- Equitable
- Sustainable
- Ensures compliance with funder and REF open access policies

#### Rights Retention Statement

 "For the purpose of open access, the author has applied [a Creative Commons Attribution (CC BY) licence or other permitted licence] to any Author Accepted Manuscript version arising".

Make clear to the publisher at time of submission that you require AM to be made open access under an open licence

Apply to all submissions

#### What do I do?

- Apply the Rights Retention Statement (RRS)
- On all your submitted manuscripts
  - In the acknowledgements and covering letter
- Deposit the accepted manuscript in Pure
  - Send to paperaccepted@abdn.ac.uk
- Use the CC BY or other open licence as appropriate
  - Be aware of funder licence requirements

#### Research Publications Policy

- New University Research Publications Policy implemented May 2023
- Contacted top publishers
- Authors achieve immediate and wide dissemination without restrictions
- Retain more rights over your own work
- Retain the freedom to publish where you see fit
- Automatically comply with funder and REF open access requirements
- Opt-out available

## Funder & REF Open Access Policies

- Research funders have OA requirements grant holders must meet
- Research Excellence Framework (REF2028)
- Immediate OA under an open licence via gold or green route
- Always choose the <u>CC BY Creative Commons license</u>
- Open Government Licence (OGL) if subject to Crown Copyright
- CC BY-ND by exception
- Limited funds for OA in Block Grants
- Publisher agreements aid compliance

## Open Access Publisher Agreements

- Agreements with major publishers
- More opportunity for open access
- Available to all UoA corresponding authors
- No funding needed
- Check the current list for agreements and participating titles
- May be a discount only on fully open access titles
  - e.g. Springer/Elsevier

#### What to consider when choosing a journal

- First check if there is a suitable title covered by the <u>publisher open access</u> agreements
- If not go green!
- Include Rights Retention Statement with submission
- Funded authors check may be able to pay an Article Processing Charge (APC)
- Some Diamond Open Access journals available which don't charge an APC
- Consider funder requirements/REF
- <u>Sherpa Services</u> or <u>Journal Checker Tool</u> check journal against funder/REF OA requirements
- Think. Check. Submit. Helps you choose a trusted journal for your publication
- Email openresearch@abdn.ac.uk

#### Adding Info to Pure

- Email paperaccepted@abdn.ac.uk when you have an article accepted
- It will be added to Pure
- The AM will be made open in AURA on publication
- Do this for all papers including Gold OA
- See your profile on the Research Portal
- Add info to Pure yourself if you like
- New researchers import your publications
- Set up automated search for publications in online sources
- Maximise your researcher profile using ORCID, SCOPUS, Pure etc.
