**Law Reports** (shelfmark *Law Rep*) are shelved alphabetically on the right hand side of the lower floor of Taylor Library, **Law Periodicals** (shelfmark *Law Per*) on the left of the lower floor. The locations **OP**, **PP**, **SP** and **EC** are in the **Official Publications Collection** in the Taylor Library. Titles with the location **e-per** are only available electronically. Please note that this list is not comprehensive and Primo should be used to ascertain whether or not a particular title is available.
