



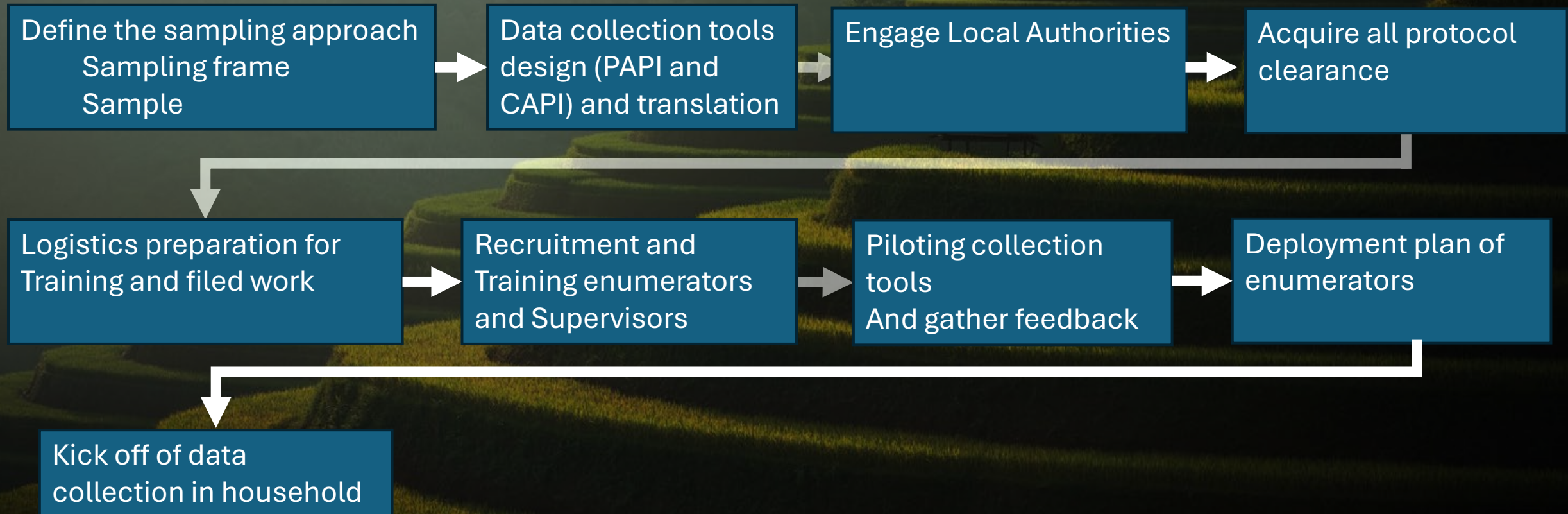

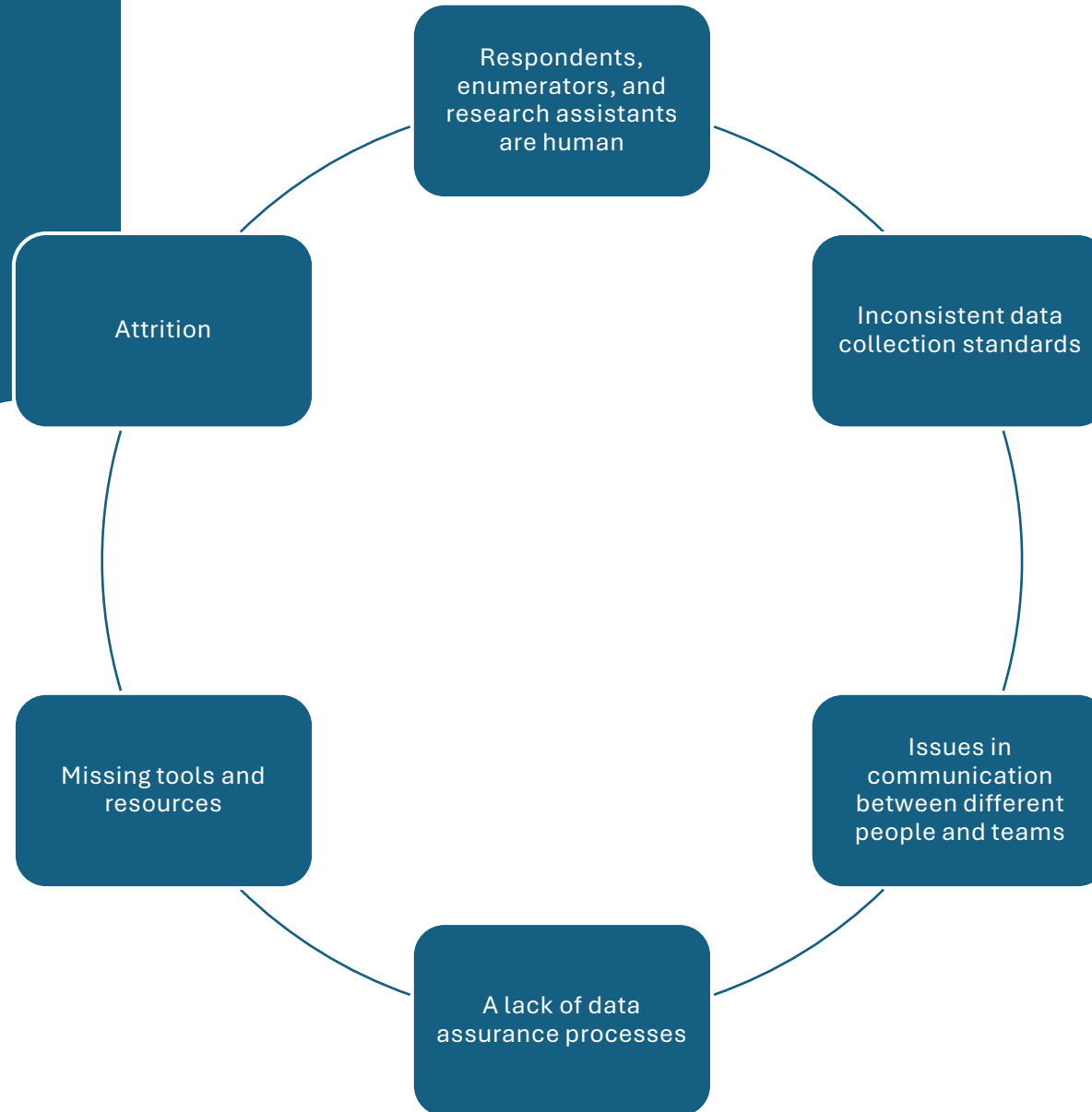

Required logistics for a survey

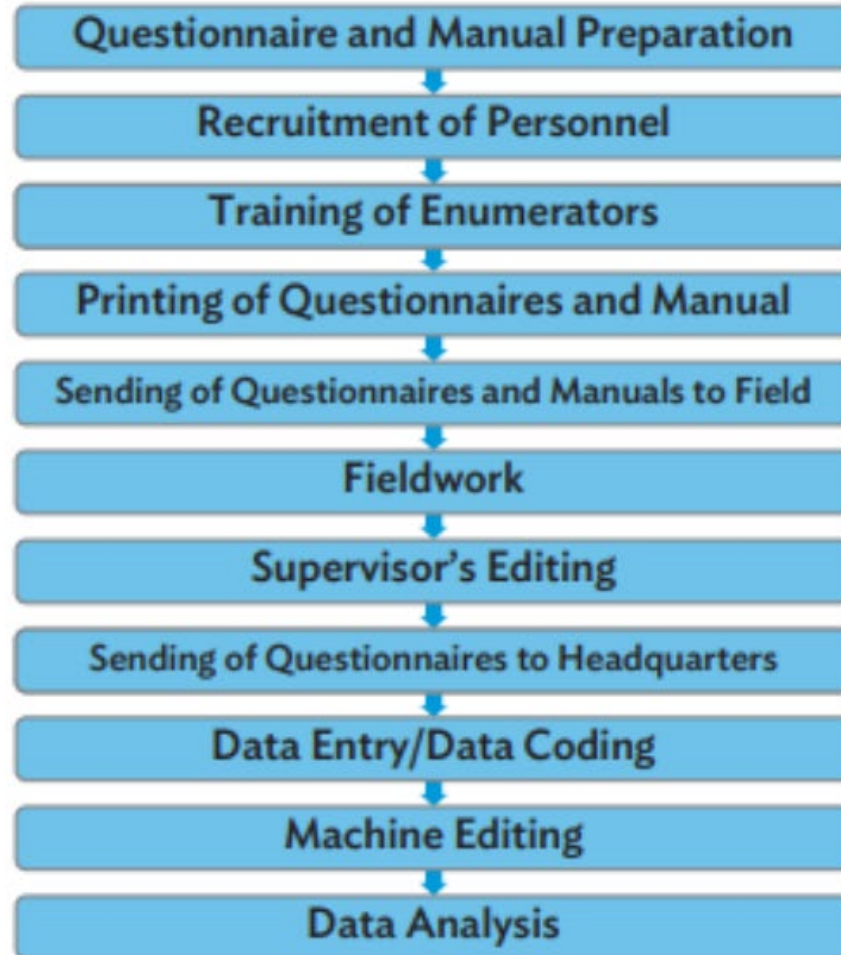
- ☐ List of selected respondents

- ☐ Data collection tools (PAPI and CAPI)
- ☐ Tablet uploaded with questionnaire
- ☐ Notebooks
- ☐ Pen or pencils
- ☐ Folder to keep the Data collection tools (PAPI and CAPI) safe
- ☐ Introduction letter + other clearance documents
- ☐ Badges for field staff
- ☐ Airtime for both enumerators and Supervisors
- ☐ Vehicles -4X4 (1 per team)
- ☐ Field allowances for all field staff

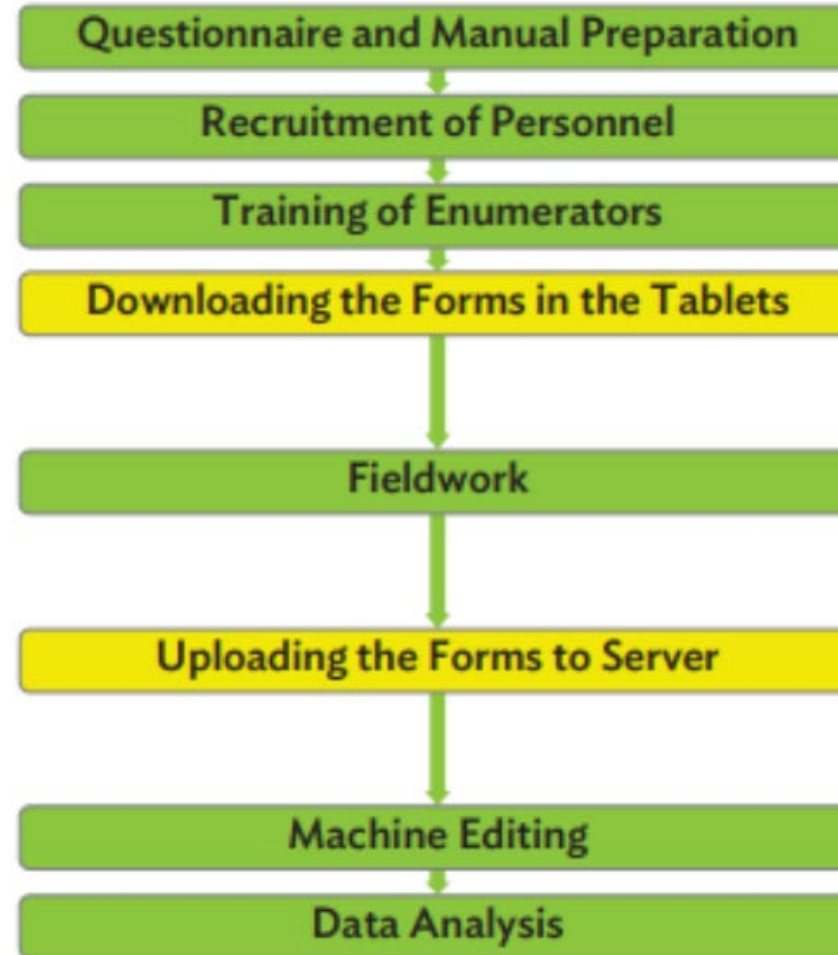

Cost-effective, sustainable solution for NSOs

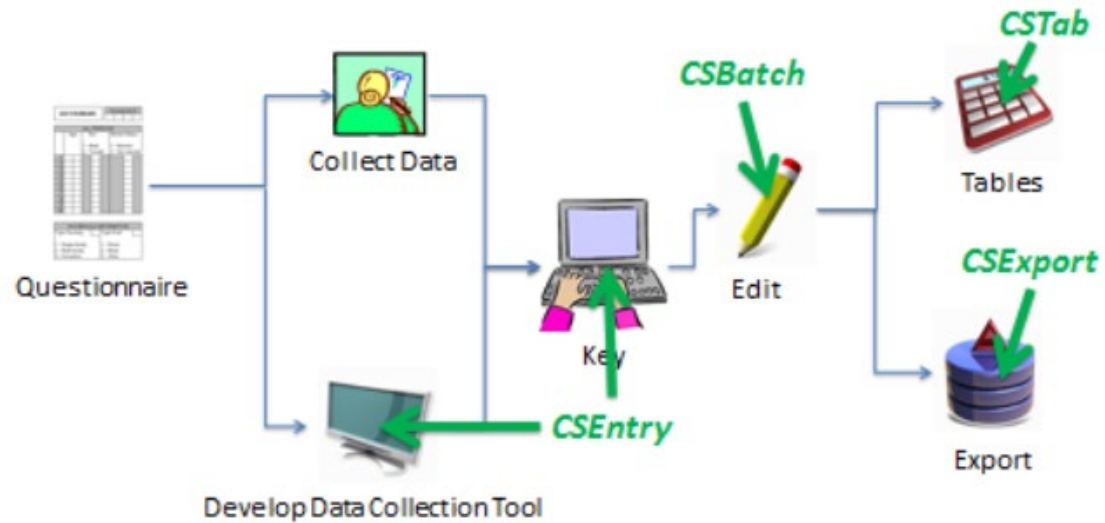

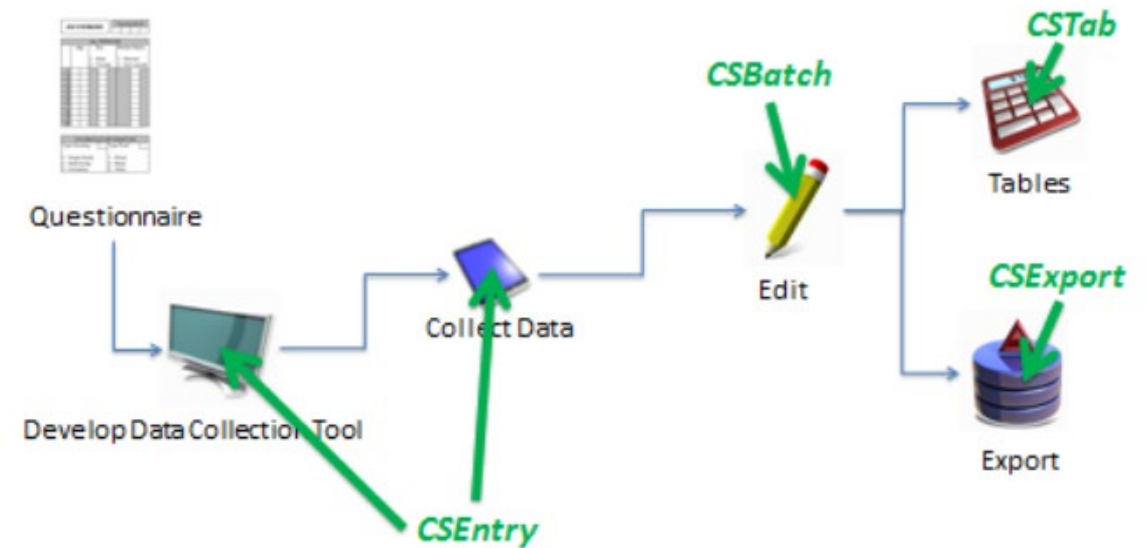
