CTR 10th Anniversary event - Wednesday 6th June 2018



2018 marks 10 years since the launch of CTR! To commemorate this, a highly enjoyable 1-day anniversary event was held on Wednesday 6th June 2018 in the Sir Duncan Rice Library. More than 40 past and current members and friends of CTR attended. The day included a programme of speakers who were invited to explore the future of mobility, an accompanying poster exhibition and plenty of time for networking and catching up.

Following a generous welcome from Prof Igor Guz (Head of School of Engineering at the University of Aberdeen), our keynote speaker, Prof Laurie Pickup (International Director, Vectos Ltd and Hon Chair of European Transport Policy, CTR), gave an intriguing talk on "Mobility futures: In search of the Oracle". This was followed by John Birtwistle's (Head of Policy, UK Bus, FirstGroup) "I have a dream..." and former CTR staff member Prof Jillian Anable (Chair of Transport and Energy, University of Leeds), who spoke on travel behaviour choice. Another former CTR colleague, Brian Masson (Managing Director, MMTS Ltd), asked "Can mobility solutions in the future be fun?". The final speaker was Prof Phil Greening (Director, Centre for Sustainable Road Freight, Heriot Watt University), who spoke on "The environmental imperative and the mobility of freight". The speaker programme was rounded off by a PechaKucha session with our current PhD students.

Sustainable shared mobility interconnected with public transport in European rural areas (developing the concept of 'smart rural transport areas' (SMARTA))



John Nelson, Mark Beecroft and Richard Mounce have been awarded a two-year project funded by the European Commission Directorate General for Mobility and Transport (DG MOVE). The research will identify good practice and carry out pilot projects on how to exploit existing mobility options and explore ways to support sustainable shared mobility interconnected with public transport in European rural areas. Mobility is a fundamental freedom that is becoming increasingly out of reach for the young, old and lower income groups in our rural areas, as dependency on private cars increases. Mature digital solutions, already flourishing in urban areas, offer a possible route out of this negative spiral, providing the means to connect people and different shared and collective modes of transport in new ways.
