Aim

Give you the opportunity to consider Medicine, Healthcare, Illness and Disability from an alternative perspective, in this case through an artist's eye.

Learning Outcomes

By the end of this course you will have;

1. Explored a number of visual outcomes developed through a range of drawing and mixed media techniques
2. Developed observation and critical skills and formulated reasoned response to the critical judgement of others
3. Developed an understanding of artistic engagement with medicine over time in a particular in relation to anatomical illustration.
4. Generate ideas of your own and creatively developed these to a final piece(s)

5. Managed your own workload and worked with others to complete the collective task of hosting the group's exhibition.
6. Demonstrated a critical and contextual understanding of issues relating to the research, development and resolution of the project.

Teaching Methods

MANDATORY SESSIONS AF15 and AM30

INTRODUCTORY SESSION on course and portfolio development

LIVE DRAWING SESSIONS variety of locations usually two per week

- Drawing in situ sessions in Anatomy dept; Zoology museum/Botanic gardens; GHAT - Suttie Art Space

Provide your own materials

- Life drawing sessions with Life models (male and female) posing both clothed and unclothed. Please discuss with course coordinator if you have any concerns about this.

Materials will be provided

Life Drawing Etiquette

- Be on time or early
- No going in and out during model posing
- No mobile phones
- No photography without permission
- Quiet during posing

LIVE 1:1 FORMATIVE FEEDBACK

- One to one portfolio discussion sessions with course tutor twice during course week 2/3 and week 4/5

EXHIBITION SEMINAR AND PLANNING SESSION

OPTIONAL CONTENT

SESSIONS

- Weekly interactive seminar on topics in art and anatomy including Artist talks
- Weekly reflect and share session
- Additional visits to sketch and view local exhibitions and galleries to consider both the work and how it is exhibited – Art Gallery and NUART

ASYNCHRONOUS TASKS

- Weekly practical guided art tasks including life drawing, anatomical drawing using mixed media techniques
- Weekly supportive videos and recordings on topics in art and anatomy approx. 1.5hrs
- Contribution to course discussion forum sharing images, ideas and reflections

Programme and timetable

You are expected to be in Aberdeen throughout the SSC unless prior permission given by SSC coordinator. Details of timetable will be posted on MyAberdeen before SSC begins – usually Monday and Friday mornings and optional sessions Wednesday pm.

Art materials

Mostly you will need to provide your own materials but these need not be expensive. In drawing sessions basic materials will be provided. An A4 sketchbook will be sufficient to form the basis of your portfolio, but you are encouraged to produce larger work and use different ground (different types and colours of paper/ cardboard/ packaging/ textiles etc....) Some materials may be available from course coordinator please ask.

You are not required to have a portfolio carrying case or anything but you might find it useful to purchase either a cheaper clear plastic sleeve available from Hobbycraft or Grays art shop to keep your work in.

You will need to prepare and mount your work to exhibit. Basic supplies needed for exhibition of work will be provided.

Library

The Library at RGU(Grays School of Art) is open to the public so you are very welcome to use the study space and to browse the book stock at any point either before or during their course. You simply need to sign in as visitors at the main reception desk in the Sir Ian Wood Building on arrival. You are not able to borrow the books.

Assessment

1. Feedback will be provided each week during reflect and share sessions and discussion boards through tutor and peer critique of work and ideas. Feedback on portfolio (Online journal) through tutor comments. Oral and written formative feedback.
2. Consideration of portfolio (Online journal) (week 2/3) and plan for final outcomes (week 4/5) for portfolio development sessions with course coordinator; Formative written feedback
3. **Artistic reflective portfolio including 300 word summary**
Summative 50%
4. **Final outcomes exhibition and final outcomes powerpoint along including 200 word artist statement and exhibition labels.**
Summative 50%

Students undertaking the ME33AF 15 credit course will have the same assessment but the expectations for final outcomes will be commensurate with the time available.

Resit will be resubmission of portfolio and/ final outcomes(s)

Reflective Art Portfolio Guidance – Online Journal

Your portfolio will be presented as an online journal in MyAberdeen and will be available or the course coordinator to view and comment on. Your portfolio is a work in progress so is not expected to be tidied up etc... You should contemporaneously, **every week**, document your project from idea generation, exploration and development to final outcomes through drawings, paintings, images as well as notes.

This should also be reflective as well and document your influences and sources. You can chose to type content or write in your sketchbook and upload photos of annotated pages.

Each week you will be given guidance on tasks to undertake to develop your ideas. You will be expected to reflect and respond to portfolio feedback meetings with the course coordinator and feedback you receive during sessions.

Summary of Criteria for reflective art portfolio

- **Experimentation and exploration** using a variety of media or techniques including use of scale and colour
- **Research and documentation of influences, sources and references** including artists, images, clinical or anatomical material, patient stories etc...
- **Documentation of process of decision making and development of ideas** showing critical awareness of own thought processes

- **Recognition that the frame of reference can change.** For example considering the subject, viewer or patient.
- **Evidence of internal dialogue**, being appropriately self-critical and displaying personal engagement with the project.
- **Taking reflection forward** consideration of learning points and impact on future artwork and career
- **Understanding of technical issues** involved in project and execution including time management

Submission and Marking Criteria

You will be required to complete your reflective art portfolio online as a journal that the course coordinator can view for discussions and feedback in week 3 and 5 and you are expected to respond reflectively to the written feedback you receive.

Fri 22nd November You will be required to submit through the course page a brief plan (300words) of your final outcomes prior to the reflective art portfolio discussions in week 4/5 and respond reflectively to the written feedback you receive. An example is available.

Weds 4th Dec 5pm you will be required to submit a word document of your artist statement transcript and exhibition labels.

Thurs 5th Dec 10am you will be required to submit your final outcome artwork and to work collaboratively to prepare for and set up the exhibition.

Thurs 5th Dec 12pm - Friday 1st December 4pm EXHIBITION in Suttle Atrium
Possibly an evening reception on Thursday at 5.30 -7pm

Friday 6th Dec 5pm the last day of week 6 you will be required to submit through Myaberdeen your;

- Completed reflective art portfolio as online journal including 300 word reflective summary (automatic submission)
- Images/photos of your final outcomes in powerpoint file with labels and artist statement

Your actual work will be retained for marking and display the earliest it can be returned is after the exam board in February.

Absences, extensions and academic misconduct

Absence
