2.	Candidates for Joint Honours in Gaelic with another subject must attend the Gaelic Language Summer school, if available, or satisfy the Programme Co-ordinator that they have accrued equivalent language experience: eg by taking a summer Gaelic work placement.
3.	Language competency levels are listed as a guide, courses may vary based on ability and are subject to diagnostic testing.
4.	Students who are completing their studies out of sync and wish to do their dissertation in Economics will be required to take their dissertation in their final half session (first half session coded course EC 4026) with the permission of the Head of Discipline.
5.	Candidates seeking entry to the Junior Honours programme must have accumulated, by award or recognition, or been exempted from, at least 240 credit points at levels 1 and 2, including the prescribed courses required to enter programme year 3.
