All candidates **must** take the following courses:

LS5098 World Trade Organisation: GATT (30 credit points)

And

LS5909 Professional Skills International Trade Negotiation (60 credits)

In addition to the above candidates must take courses to the value of 60 credit points. At least 30 credit points must be obtained from the courses listed below. The remaining credit points may be obtained from any Level 5 30 credit on campus Law courses (excluding LS501K and any of the other Professional Skills courses, LS5905, LS5906, LS5907, LS5908, and LS5913):

Assessment: By course work, by written examination, or by a combination of these, as prescribed for each course. The degree of LLM shall not be awarded to a candidate who fails to achieve a CGS grade of D3 or above in the specified dissertation course, irrespective of their performance in other courses: such candidates may, at the discretion of the Examiners, be awarded a Postgraduate Diploma or Postgraduate Certificate.

PART TIME ROUTE

This route will run over two academic years minimum. Candidates can take up to 120 credit points in an academic year.

LS501T must be taken in Year 1, and

LS5909 must be taken in Year 2.

Candidates must also take the following. They can be taken in either Year 1 or Year 2:

Candidates must take a remaining 60 credit points. At least 60 credit points must be obtained from the courses listed below.
