

INTERNATIONAL TRADE LAW AND TREATY NEGOTIATION (BLENDED)

Duration: 12 months full-time, normally 24 months part-time.

Content:

Full Time students take 60 credits per semester. Part time normally take 30 credits per semester.

SEPTEMBER
