Notes

1.	One Honours course (other than the dissertation) may be replaced by a Level 4 course from another discipline with the permission of the Senatus Academicus.
2.	Normally the year abroad is taken at the end of a student's second year but with the permission of the Law School Go Abroad Tutors it may be possible, exceptionally, to allow a student to study abroad at the end of his or her Junior Honours year (ie at the end of third year).
3.	Candidates seeking entry to the Junior Honours programme must have accumulated, by award or recognition, or been exempted from, at least 240 credit points at levels 1 and 2, including those compulsory courses required to enter programme year 3.
