## Scholarships and Bursaries

### 2024 Entry

The University of Aberdeen is committed to attracting the very best students, regardless of financial circumstances, which is why we offer a large number of scholarships to undergraduate students.

For 2024 entry, our scholarships are available based on two criteria: Access and Merit. Scholarships based on "Access" are there to support those who may otherwise struggle to meet the cost of studies, while "Merit" scholarships are designed for those who have shown considerable academic potential in their A Level results. Students meeting the criteria of both scholarships are entitled to receive both payments, potentially £8,000 in their first year. Payments are made in early April. The scholarships are not available to graduate students undertaking further study.

#### Access Scholarship - 2024 Entry

This is a means tested scholarship payable each year of study. Students whose residual household income, as declared to the Student Loans Company, is below £20,360 per year will receive £3,000 a year for each year of study.

#### Merit Scholarship - 2024 Entry

There are two Merit Scholarships available: students not eligible for Merit Scholarship A may be eligible for Merit Scholarship B. Please note that Medicine is not eligible for either Merit scholarship. Full conditions can be found online.

#### Merit Scholarship A

AAA achieved at A Level - £5,000 paid in academic year 2024/25 only.

AAB or ABB achieved at A Level - £3,000 paid in academic year 2024/25 only.

#### Merit Scholarship B (Entrance Award)

Students joining us in September 2024 who do not meet Merit Scholarship A will receive £1,000 paid in academic year 2024/25 only.

Please note that all stated scholarship amounts are only applicable to undergraduate students commencing study at Aberdeen in 2024, paying the "rest of UK" fee rate of £9,250 per year. The stated scholarships do not apply to 2024 entry or beyond. The Access Scholarship is only paid if the fees due in the academic year are £9,250.



## Our Tuition Fees 2024 Entry

We're committed to making sure that those who wish to enjoy the benefits of a four-year Scottish degree can do so, whilst at the same time providing advanced entry options for well qualified students who wish to gain an Honours degree in three years.

#### **Our Tuition Fees**

Tuition fees for 2022 entry will be £9,250 a year at Aberdeen. There are no up-front tuition fees and students can apply for a government loan to cover the fees. This loan does not have to be re-paid until after graduation.

Students from England, Wales or Northern Ireland can apply for a tuition fee loan, as well as support for their day-to-day costs, from Student Finance in their nation. Students who are Irish nationals domiciled in the Republic of Ireland can apply to Student Awards Agency Scotland (SAAS) for a tuition fee loan only.
