Keynote Speaker - Professor Anne-Michelle Slater

Professor Anne-Michelle Slater is a Professor of Planning and Environmental Law at the University of Aberdeen School of Law, where she previously served as Head of the School of Law. She currently holds senior leadership roles within the University, including Dean for Portfolio Development and Programme Promotion. Her research and teaching expertise span environmental law, marine spatial planning, offshore renewable energy governance, and public participation in environmental decision-making.

Professor Slater has played a leading role in advancing equality, diversity, and inclusion within the School of Law. In 2024, she led the School's successful renewal of its Athena SWAN Bronze Award, demonstrating the School's sustained commitment to gender equality and an inclusive academic culture.

She has served on the Royal Town Planning Institute's Marine Spatial Planning Task Group and the Scottish Government's Sustainable Seas Task Force. In addition to her academic leadership, she is a member of the Law Society of Scotland Marine Law Committee and sits on the editorial boards of leading journals including Environmental Law Review, Scottish Planning and Environmental Law, and the Journal of Water Law.

Her work is also characterised by interdisciplinarity and robust policy engagement. She has advised the Scottish Government and the Irish Marine Institute on marine spatial planning and has contributed extensively to research on environmental governance and marine renewable energy regulation. She is currently involved in the ValMAS Project, a £5.6 million interdisciplinary research partnership between the UK and Norway examining the ecological, societal, and regulatory value of marine artificial structures in the North Sea within the context of the energy transition over the next three years. Within the project, Professor Slater evaluates the policy and legislative frameworks governing marine artificial structures and their role in achieving environmentally sustainable and socially equitable offshore energy development.

3-Minute Thesis Presentation

Three Minute Thesis (3MT) is a competition that began at The University of Queensland. It challenges PhD researchers to present their work in only three minutes, using a single static PowerPoint slide.

At this conference, the aim is to allow students from the law school to practice their presentation skills and hone their ability to be concise. While not a formal competition, we hope to encourage students to engage with the wider faculty and refine their ability to present their research with brevity.

Professor Donna McKenzie Skene is Emeritus Professor of Law at the University of Aberdeen. She is a leading authority on insolvency and bankruptcy law, with particular expertise in Scottish and comparative perspectives. Her scholarship has shaped understanding of corporate insolvency and contributed to law reform discussions, making her a respected figure in commercial law research.

Professor Abbe Brown is Professor of Intellectual Property Law at the University of Aberdeen. Her research examines the intersections of intellectual property and societal challenges. She has attended major international forums, including UNFCCC COP26 and the WIPO Diplomatic Conference, as part of academic and policy delegations. A former solicitor in London, Melbourne, and Edinburgh, she is a Fellow of the Royal Society of Edinburgh and an active contributor to policy consultations and international legal debates.

Dr Nevena Jevremovic is Lecturer in Law at the University of Aberdeen. Her interdisciplinary research explores the relationship between law, language, and power in both private and international law. She holds a PhD in Law from the University of Zenica and LL.M. degrees from Pittsburgh and Sarajevo. Alongside her academic work, she has practical legal experience as an associate at Wolf Theiss in Bosnia and Herzegovina and has been extensively involved in the Willem C. Vis International Arbitration Moot.
