### Supplementary Regulations for the Degree of Bachelor of Laws (LLB)

- 1. The degree of Bachelor of Laws (LLB) may be conferred in one of two forms: either as the Degree of LLB or as the Degree of LLB with Honours. The degree shall not be conferred honoris causa tantum.
- 2. Subject to the provisions of Supplementary Regulations 3 to 5 every candidate for the Degree of LLB must obtain a minimum of 360 credit points. Candidates first enrolled during or after 2003/2004 must obtain a minimum of 60 credit points at level 3 or above in LS courses. Every candidate must be in attendance on classes for the following minimum periods, unless granted exemption by the Senatus Academicus, before applying for the degree. Candidates already in possession of a degree before registering for the LLB are normally granted such
  - (i) Candidates for the degree by full-time study only: not less than three sessions
  - (ii) Candidates for the degree by part-time study only: not less than five sessions.
  - (iii) Candidates for the degree by a combination of both part-time and full-time study: such period as may be determined in individual cases by the Senatus Academicus For the purpose of this Regulation two terms of part-time study shall be counted as the equivalent of one term of full-time study
- 3. Every candidate must include in their curriculum and have passed the prescribed degree assessment in the compulsory courses for their particular degree programme as listed in the programme prescription.
- 4. The minimum 360 credit points required for the award of the Degree must not include credit points from the course Business Law.
- 5. Candidates who have fulfilled the requirements of Supplementary Regulations 2 to 4 and of the General Degree Regulations shall be entitled to apply for the Degree of LLB. Any such candidates for the degree who have successfully completed the courses detailed in the relevant section of programme prescriptions will be entitled to have their degree certificate endorsed in accordance with the programmes listed in the University Calendar: <a href="https://www.abdn.ac.uk/registry/calendar/law.php">https://www.abdn.ac.uk/registry/calendar/law.php</a>
- 6. Subject to Regulation 16.1(c). of the General Regulations for First Degrees, a candidate who has completed programme year 3 of the non-honours degree and has fulfilled the requirements of Supplementary Regulations 2 to 4 may, with the permission of the Senatus Academicus, progress from programme year 3 of the non-honours degree programme to year 3 of the Honours degree programme.

A candidate may, if they meet the eligibility criteria set out by the Go Abroad office, spend one academic year or part of one academic year at an Educational Institution with which the University has an existing agreement under the International Exchange Programme. After the period of study abroad the host university produces an academic record and the Senatus Academicus must be satisfied that the equivalent of 120 Aberdeen credits have been earned (120 credit points where a full year has been spent abroad and 60 where a half year has been spent abroad), or that a credit waiver can be applied in accordance with the University's General Regulations.

#### REGULATIONS FOR AWARD OF THE DEGREE WITH HONOURS

7. Candidates for the Degree of LLB with Honours, must obtain at least 480 credit points, and must comply with the provisions of Supplementary Regulation 3.

- 8. Candidates must attend courses of instruction in an Honours programme comprising a dissertation and any six of the courses offered for the Degree of LLB with Honours, as specified in Annex A.
  - (i) Excepting Candidates who have undertaken an approved period of study abroad during programme year 3. In this case:
    - a. Candidates undertaking the second term of programme year 3 abroad (applicable to the Degree of LLB with Honours) must attend courses of instruction in an Honours programme comprising a dissertation and any five of the courses offered, as specified in Annex A.
    - b. Candidates undertaking programme year 3 in full abroad (applicable to the Degree of LLB in International Law and Comparative Law only) must attend course of instruction in an Honours programme comprising a dissertation and any four of the courses prescribed for the degree, as specified in Annex A.
  - (ii) One of these Honours/Annex A courses may be replaced by a Level 4 course from another School, with the permission of the Senatus Academicus.
- 9. Candidates for the Degree of LLB with Honours must have their dissertation topic approved by an appropriate member of the staff of the School of Law. Candidates shall submit their dissertation in the Senior Honours session by the relevant date as publicised by the School, unless, in exceptional circumstances, the prior permission of the Senatus Academicus has been obtained. Candidates who do not comply with this regulation may be subject to such punitive action as may be decided by the Board of Examiners for the Honours programme.
- 10. Candidates who have fulfilled the requirements of Supplementary Regulations 7 and 8 and of the General Degree Regulations shall be entitled to apply for the Degree of LLB with Honours. Any such candidates who have already had the Degree of LLB conferred upon them shall be entitled to receive a certificate stating the class of Honours awarded to them. Any such candidates who have successfully completed the courses detailed in the relevant section of programme prescriptions will be entitled to have their degree certificate endorsed in accordance with the programmes listed in the University Calendar: https://www.abdn.ac.uk/registry/calendar/law.php

## Supplementary Regulations for the Degree of Bachelor of Laws (LLB) with English Law

- 11. The degree of Bachelor of Laws (LLB) with English Law may be conferred in one of two forms: either as the Degree of LLB or as the Degree of LLB with Honours. The degree shall not be conferred honoris causa tantum.
- 12. Subject to the provisions of Supplementary Regulations 3 to 5 every candidate for the Degree of LLB must obtain a minimum of 360 credit points. Candidates first enrolled during or after 2003/2004 must obtain a minimum of 60 credit points at level 3 or above in LS courses. Every candidate must be in attendance on classes for the following minimum periods, unless granted exemption by the Senatus Academicus, before applying for the degree. Candidates already in possession of a degree before registering for the LLB are normally granted such exemption.
  - (i) Candidates for the degree by full-time study only: not less than three sessions.
  - (ii) Candidates for the degree by part-time study only: not less than five sessions.
  - (iii) Candidates for the degree by a combination of both part-time and full-time study: such period as may be determined in individual cases by the Senatus Academicus For the purpose of this Regulation two terms of part-time study shall be counted as the equivalent of one term of full-time study.
- 13. Every candidate must include in their curriculum and have passed the prescribed degree assessment in the compulsory courses for their particular degree programme as listed in the programme prescription.
- 14. The minimum 360 credit points required for the award of the Degree must not include credit points from the course Business Law.
- 15. Candidates who have fulfilled the requirements of Supplementary Regulations 2 to 4 and of the General Degree Regulations shall be entitled to apply for the Degree of LLB. Any such candidates for the degree who have successfully completed the courses detailed in the relevant section of programme prescriptions will be entitled to have their degree certificate endorsed in accordance with the programmes listed in the University Calendar: <a href="https://www.abdn.ac.uk/registry/calendar/law.php">https://www.abdn.ac.uk/registry/calendar/law.php</a>
- 16. Subject to Regulation 16.1(c). of the General Regulations for First Degrees, a candidate who has completed programme year 3 of the non-honours degree and has fulfilled the requirements of Supplementary Regulations 2 to 4 may, with the permission of the Senatus Academicus, progress from programme year 3 of the non-honours degree programme to year 3 of the Honours degree programme.
- 17. A candidate may, if they meet the eligibility criteria set out by the Go Abroad office, spend one academic year or part of one academic year at an Educational Institution with which the University has an existing agreement under the International Exchange Programme. After the period of study abroad the host university produces an academic record and the Senatus Academicus must be satisfied that either the equivalent of Aberdeen credits have been earned (120 credit points where a full year has been spent abroad and 60 where a half year has been spent abroad), or that a credit waiver can be applied in accordance with the University's General Regulations.

#### REGULATIONS FOR AWARD OF THE DEGREE WITH HONOURS

18. Candidates for the Degree of LLB with English Law Honours, must obtain at least 480 credit points, and must comply with the provisions of Supplementary Regulation 3.

- 19. Candidates must attend courses of instruction in an Honours programme comprising a dissertation and any six of the courses offered for the Degree of LLB with Honours, as specified in Annex A.
  - (i) Excepting Candidates who have undertaken an approved period of study abroad during the second term of programme year 3. In this case Candidates must attend courses of instruction in an Honours programme comprising a dissertation, any five of the courses offered for the Degree of LLB with Honours, as specified in Annex A.
  - (ii) One of these Honours/Annex A courses may be replaced by a Level 4 course from another School, with the permission of the Senatus Academicus. In addition, English Property Law must be undertaken in programme year 4.
- 20. Candidates for the Degree of LLB with Honours must have their dissertation topic approved by an appropriate member of the staff of the School of Law. Candidates shall submit their dissertation in the Senior Honours session by the relevant date as publicised by the School, unless, in exceptional circumstances, the prior permission of the Senatus Academicus has been obtained. Candidates who do not comply with this regulation may be subject to such punitive action as may be decided by the Board of Examiners for the Honours programme.
- 21. Candidates who have fulfilled the requirements of Supplementary Regulations 7 and 8 and of the General Degree Regulations shall be entitled to apply for the Degree of LLB with Honours. Any such candidates who have already had the Degree of LLB conferred upon them shall be entitled to receive a certificate stating the class of Honours awarded to them. Any such candidates who have successfully completed the courses detailed in the relevant section of programme prescriptions will be entitled to have their degree certificate endorsed in accordance with programmes listed University Calendar: the in the https://www.abdn.ac.uk/registry/calendar/law.php

#### Supplementary Regulations for the Degree Bachelor of Laws and French Law (LLB and French Law)

- 22. The Degree of LLB and French Law extends over four sessions of full-time study or the equivalent. The Degree of LLB and French Law with Honours extends over five sessions of full-time study or the equivalent. For both degrees, candidates must spend a session of study, normally in programme year three except with permission of the Senatus Acadmicus, at an Educational Institution with which the School of Law has an existing agreement. This portion of the degree must be taken on a full-time basis.
- 23. To be eligible to study at an Educational Institution with which the School of Law has an agreement, unless granted exemption by the Senatus Academicus, candidates must have passed by the end of their second session of full-time study or the equivalent; all the courses prescribed for programme years 1 and 2 in the programme prescription, at least 210 credit points over programme years 1 and 2, and the pre-requisite courses for entry into programme year 4.
- 24. During their session at one or other educational institution candidates shall be assessed in accordance with the procedures in force at the relevant Institution.
- 25. Candidates who pass the relevant courses prescribed for programme year 3 as indicated in the programme prescription shall be awarded a qualification (e.g. Diploma or Certificate) as appropriate and in accordance with the agreement between that Institution and the School of Law.
- 26. Except with the permission of the Senatus Academicus or where General Regulation 16.1 applies candidates may not progress into:
  - (i) Junior Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 360 credit points over levels 1 to 3 [including those required to enter programme year 4 for the degree of Bachelor of Laws and French Law];
  - (ii) Non- Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 330 credit points over levels 1 to 3 [including those required to enter programme year 4 for the Degree of Bachelor of Laws and French Law (Non-Honours)];
  - (iii) Junior Honours, programme year 3, of the LLB Hons or LLB Hons with Options in French Language unless they have accumulated, by award or recognition, or been exempted from, at least 240 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 17;
  - (iv) Non- Honours, programme year 3, of the LLB or LLB with Options in French Language unless they have accumulated, by award or recognition, or been exempted from, at least 210 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 17;
- 27. Candidates shall be entitled to graduate with the Degree of LLB and French Law if they have:
  - (i) fulfilled the requirements of Regulations 2 to 4 of the LLB Supplementary Regulations, and of the General Degree Regulations;
  - (ii) successfully completed, or been granted exemption from all the courses detailed in the programme prescription; and
  - (iii) successfully completed the qualification required by the agreement between that Educational Institution and the School of Law.

- 28. Candidates shall be entitled to graduate with the Degree of LLB Honours and French Law if they have satisfied the provisions of Supplementary Regulation 16 and have fulfilled the requirements of Regulations 8 and 9 of the LLB Supplementary Regulations, and of the General Degree Regulations.
- 29. A candidate shall immediately inform his or her Go Abroad Tutor at Aberdeen and the relevant Educational Institution if he or she is unable to attend classes for a period longer than two continuous weeks, or fails to take examinations or to complete any required course assessment. In the case of illness he or she shall send a copy of a medical certificate to the Law School and to the Go Abroad Tutor of Aberdeen University; and in any other case shall submit reasons in writing to the Go Abroad Tutor explaining the absence or failure to complete a required course assessment.
- 30. A candidate who does not obtain the qualification required by the agreement between that Educational Institution and the School of Law will not be allowed to continue with the Degree of LLB and French Law but will normally be required to transfer to the Degree of LLB, or the Degree of LLB with Honours, or one of these forms of the degree with Options in French Language as determined in Supplementary Regulation 26 (iii) and (iv).

#### Supplementary Regulations for the Degree Bachelor of Laws and German Law (LLB and German Law)

- 31. The Degree of LLB and German Law extends over four sessions of full-time study or the equivalent. The Degree of LLB and German Law with Honours extends over five sessions of full-time study or the equivalent. For both degrees, candidates must spend a session of study, normally in programme year three except with permission of the Senatus Academicus at an Educational Institution with which the School of Law has an existing agreement. This portion of the degree must be taken on a full-time basis.
- 32. To be eligible to study at the an Educational Institution with which the School of Law has an agreement, unless granted exemption by the Senatus Academicus, candidates must have passed by the end of their second session of full-time study or the equivalent; all the courses prescribed for programme years 1 and 2 in the programme prescription, at least 210 credit points over programme years 1 and 2, and the pre-requisite courses for entry into programme year 4.
- 33. During their session at one or other Educational Institution candidates shall be assessed in accordance with the procedures in force at the relevant Institution.
- 34. Candidates who pass the relevant courses prescribed for programme year 3 as indicated in the programme prescription shall be awarded a qualification (e.g. Diploma or Certificate) as appropriate and in accordance with the agreement between that Institution and the School of Law.
- 35. Except with the permission of the Senatus Academicus or where General Regulation 16.1 applies candidates may not progress into:
  - (i) Junior Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 360 credit points over levels 1 to 3 [including those required to enter programme year 4 for the degree of Bachelor of Laws and German Law];
  - (ii) Non- Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 330 credit points over levels 1 to 3 [including those required to enter programme year 4 for the Degree of Bachelor of Laws and German Law (Non-Honours)];
  - (iii) Junior Honours, programme year 3, of the LLB Hons or LLB Hons with Options in German Language unless they have accumulated, by award or recognition, or been exempted from, at least 240 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 37;
  - (iv) Non- Honours, programme year 3, of the LLB or LLB with Options in German Language unless they have accumulated, by award or recognition, or been exempted from, at least 210 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 37;
- 36. Candidates shall be entitled to graduate with the Degree of LLB and German Law if they have:
  - (i) fulfilled the requirements of Regulations 2 to 4 of the LLB Supplementary Regulations, and of the General Degree Regulations;
  - (ii) successfully completed, or been granted exemption from, all the courses detailed in the programme prescription; and
  - (iii) successfully completed the qualification required by the agreement between that Educational Institution and the School of Law.

- 37. Candidates shall be entitled to graduate with the Degree of LLB Honours and German Law if they have satisfied the provisions of Supplementary Regulation 25 and have fulfilled the requirements of Regulations 8 and 9 of the LLB Supplementary Regulations, and Regulations 8 and 9 of the General Degree Regulations.
- 38. A candidate shall immediately inform his or her Go Abroad Tutor at Aberdeen and the relevant Educational Institution if he or she is unable to attend classes for a period longer than two continuous weeks, or fails to take examinations or to complete any required course assessment. In the case of illness he or she shall send a copy of a medical certificate to the Law School and to the Go Abroad Tutor of Aberdeen University; and in any other case shall submit reasons in writing to the Go Abroad Tutor explaining the absence or failure to complete a required course assessment.

A candidate who does not take or fails any assessment required for the award of the Certificate in German Law or the Diploma in German Law or 60 ECTS credit points from Marburg University will not be allowed to continue with the Degree of Law and German Law but will normally be required to transfer to the Degree of LLB, or the Degree of LLB with Honours, or one of these forms of the degree with Options in German Language as determined in Supplementary Regulation 35 (iii).

### Supplementary Regulations for the Degree Bachelor of Laws and Spanish Law (LLB and Spanish Law)

- 39. The Degree of LLB and Spanish Law extends over four sessions of full-time study or the equivalent. The Degree of LLB and Spanish Law with Honours extends over five sessions of full-time study or the equivalent. For both degrees, candidates must spend a session of study, normally in programme year three except with permission of the Senatus Academicus, at an educational institution with which the School of Law has an existing agreement where the medium of instruction is Spanish Language. This portion of the degree must be taken on a full-time basis.
- 40. To be eligible to study at an educational institution with which the School of Law has an agreement unless granted exemption by the Senatus Academicus, candidates must have passed by the end of their second session of full-time study or the equivalent; all the courses prescribed for programme years 1 and 2 in the programme prescription, at least 210 credit points over programme years 1 and 2, and the pre-requisite courses for entry into programme year 4.
- 41. During their session at one or other educational institution candidates shall be assessed in accordance with the procedures in force at the relevant Institution.
- 42. Candidates who pass the relevant courses prescribed for programme year 3 as indicated in the programme prescription shall be awarded a qualification (e.g. Diploma or Certificate) as appropriate and in accordance with the agreement between that Institution and the School of Law.
- 43. Except with the permission of the Senatus Academicus or where General Regulation 16.1 applies candidates may not progress into:
  - (i) Junior Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 360 credit points over levels 1 to 3 [including those required to enter programme year 4 for the degree of Bachelor of Laws and Spanish Law];
  - (ii) Non- Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 330 credit points over levels 1 to 3 [including those required to enter programme year 4 for the Degree of Bachelor of Laws and Spanish Law (Non-Honours)];
  - (iii) Junior Honours, programme year 3, of the LLB Hons or LLB Hons with Options in Spanish Language unless they have accumulated, by award or recognition, or been exempted from, at least 240 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 45;
  - (iv) Non- Honours, programme year 3, of the LLB or LLB with Options in Spanish Language unless they have accumulated, by award or recognition, or been exempted from, at least 210 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 45.
- 44. Candidates shall be entitled to graduate with the Degree of LLB and Spanish Law if they have:
  - (i) fulfilled the requirements of Regulations 2 to 4 of the LLB Supplementary Regulations, and of the General Regulations;
  - (ii) successfully completed, or been granted exemption, in all the courses detailed in programme prescriptions;
  - (iii) successfully completed the qualification required by the agreement between that Educational Institution and the School of Law.

- 45. Candidates shall be entitled to graduate with the Degree of LLB (Honours) and Spanish Law LLB if they have satisfied the provisions of Supplementary Regulation 43 and have fulfilled the requirements of Regulations 8 and 9 of the LLB Supplementary Regulations, and of the General Degree Regulations.
- 46. A candidate shall immediately inform his or her Go Abroad Tutor at Aberdeen and the relevant Educational Institution if he or she is unable to attend classes for a period longer than two continuous weeks, or fails to take examinations or to complete any required course assessment. In the case of illness he or she shall send a copy of a medical certificate to the Law School and to the Go Abroad Tutor at Aberdeen University; and in any other case shall submit reasons in writing to the Go Abroad Tutor explaining the absence or failure to complete a required course assessment.
- 47. A candidate who does not take or fails any assessment required for the award of the Certificate in Spanish Law will not be allowed to continue with the Degree of Law and Spanish Law but will normally be required to transfer to the Degree of LLB, or the Degree of LLB with Honours, or one of these forms of the degree with Options in Spanish Language as determined in Supplementary Regulation 43 (III) and (IV).

# Supplementary Regulations for the Degree Bachelor of Laws and European Legal Studies (LLB and European Legal Studies)

- 48. The Degree of LLB and European Legal Studies extends over four sessions of full-time study or the equivalent. The Degree of LLB and European Legal Studies with Honours extends over five sessions of full-time study or the equivalent. For both degrees, candidates must spend a session of study, normally in programme year three except with permission of the Senatus Academicus, abroad under a contract at one of the approved host Universities specified in programme prescriptions where the medium of instruction is English. This portion of the degree must be taken on a full-time basis.
- 49. To be eligible to study at one of the host Universities, unless granted exemption by the Senatus Academicus, candidates must have passed by the end of their second session of full-time study or the equivalent; all the courses prescribed for programme years 1 and 2 in the programme prescription, at least 210 credit points over programme years 1 and 2, and the pre-requisite courses for entry into programme year 4.
- 50. During their session at the host University, candidates shall be assessed in accordance with the procedures in force at that University.
- 51. The candidate's proposed programme of study at the host University must be approved by the appropriate Go Abroad Tutors of both host and sending Universities.
- 52. Except with the permission of the Senatus Academicus or where General Regulation 16.1 applies candidates may not progress into:
  - (i) Junior Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 360 credit points over levels 1 to 3 [including those required to enter programme year 4 for the degree of Bachelor of Laws and European Legal Studies];
  - (ii) Non- Honours, programme year 4, unless they have accumulated, by award or recognition, or been exempted from, at least 330 credit points over levels 1 to 3 [including those required to enter programme year 4 for the Degree of Bachelor of Laws and European Legal Studies (Non-Honours)];
  - (iii) Junior Honours, programme year 3, of the LLB Hons unless they have accumulated, by award or recognition, or been exempted from, at least 240 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 53;
  - (iv) Non- Honours, programme year 3, of the LLB unless they have accumulated, by award or recognition, or been exempted from, at least 210 credit points over levels 1 to 3 [including those required to enter programme year 3 of the degree programme they are transferring to] in accordance with Supplementary Regulation 53;
  - 53. Candidates will be required to attend and pass the required assessment in courses approved under Supplementary Regulation 49 which aggregate at least 60 credit points under the European Credit Transfer Scheme (ECTS).
    - (i) Candidates shall be entitled to graduate with the Degree of LLB and European Legal Studies if they have: fulfilled the requirements of Regulations 2 to 4 of the LLB Supplementary Regulations, and of the General Degree Regulations;
    - (ii) successfully completed, or been granted exemption in, all the courses detailed in the programme prescription, and
    - (iii) fulfilled the requirement of Supplementary Regulation 50.

- 54. Candidates shall be entitled to graduate with the Degree of LLB Honours and European Legal Studies if they have satisfied the provisions of Supplementary Regulation 52 and have fulfilled the requirements of Regulations 8 and 9 of the LLB Supplementary Regulations, and Regulations 8 and 9 of the General Degree Regulations.
- 55. A candidate shall immediately inform his or her Go Abroad Tutor at Aberdeen and the host University if he or she is unable to attend courses at their host institution for a period longer than two continuous weeks, or fails to take examinations or to complete any required course assessment. In the case of illness he or she shall send a copy of a medical certificate to the Law School and to the Go Abroad Tutor at Aberdeen University; and in any other case shall submit reasons in writing to the Go Abroad Tutor explaining the absence or failure to complete a required course assessment.
- 56. A candidate who does not obtain the necessary 60 ECTS credit points at the host University will not be allowed to continue with the Degree of LLB and European Legal Studies but will normally be required to transfer to the Degree of LLB, or the Degree of LLB with Honours as determined in Supplementary Regulation 52 (iii) and (iv).

#### Supplementary Regulations for the Degree Bachelor of Laws (LLB) Accelerated

- 57. The degree of Bachelor of Laws (LLB) will be conferred as the Degree of LLB. The degree shall not be conferred honoris causa tantum.
- 58. Subject to the provisions of Supplementary Regulations 58 to 59 every candidate for the Degree of LLB must obtain a minimum of 360 credit points. Candidates already in possession of a degree before registering for the LLB Accelerated will be awarded 120 credits of recognitions upon entry to the Degree. Candidates will be awarded 90 Level 1 unspecified recognitions, and 30 Level 3 unspecified recognitions. Candidates first enrolled during or after 2003/2004 must obtain a minimum of 60 credit points at level 3, with 30 credits in LS courses and 30 credits of Level 3 unspecified recognitions. Every candidate must be in attendance on classes for the following minimum periods, unless granted exemption by the Senatus Academicus, before applying for the degree.
  - (i) Candidates for the degree by full-time study only: not less than two sessions.
  - (ii) Candidates for the degree by part-time study only: not less than four sessions.
- 59. Every candidate must include in their curriculum and have passed the prescribed degree assessment in the compulsory courses for their particular degree programme as listed in the programme prescription.
- 60. The minimum 360 credit points required for the award of the Degree must not include credit points from the course Business Law.
- 61. Candidates who have fulfilled the requirements of Supplementary Regulations 57 to 59 and of the General Degree Regulations shall be entitled to apply for the Degree of LLB.

#### Supplementary Regulations for the Degree of Bachelor of Laws with English Law (LLB) Accelerated

- 62. The degree of Bachelor of Laws (LLB) will be conferred as the Degree of LLB. The degree shall not be conferred honoris causa tantum.
- 63. Subject to the provisions of Supplementary Regulations 63 to 64 every candidate for the Degree of LLB must obtain a minimum of 390 credit points. Candidates already in possession of a degree before registering for the LLB Accelerated will be awarded 120 credits of recognitions upon entry to the Degree. Candidates will be awarded 120 Level 1 unspecified recognitions. Candidates first enrolled during or after 2003/2004 must obtain a minimum of 60 credit points at level 3 or above in LS courses. Every candidate must be in attendance on classes for the following minimum periods, unless granted exemption by the Senatus Academicus, before applying for the degree.
  - (i) Candidates for the degree by full-time study only: not less than two sessions.
  - (ii) Candidates for the degree by part-time study only: not less than four sessions.
- 64. Every candidate must include in their curriculum and have passed the prescribed degree assessment in the compulsory courses for their particular degree programme as listed in the programme prescription.
- 65. The minimum 390 credit points required for the award of the Degree must not include credit points from the course Business Law.
- 66. Candidates who have fulfilled the requirements of Supplementary Regulations 62 to 64 and of the General

### Supplementary Regulations for the award of Diploma in Legal Studies

- 67. Admission to the programme of study leading to the award by the University of Aberdeen of the Diploma in Legal Studies is open only to law students from Educational Institutions with which the School of Law has an existing agreement.
- 68. The programme for the Diploma shall extend over one session of full-time study, undertaken at the University of Aberdeen.
- 69. Candidates who have attended and duly performed the work of the class and passed the prescribed degree assessments in the subjects required under Annex B, shall be eligible for the award of the Diploma in Legal Studies from the University of Aberdeen.
