2	Students are required to have exactly 240 credits at levels 3 and 4, at least 210 of which must be AC, EC, FI, IB or MS coded, and. At least 90 credits must be at level 4.
2	The Accountancy specialism is NOT accredited by the accountancy professional bodies.
3	Students need to follow a specialism through years 1 and 2 to ensure that they have sufficient prerequisites to follow courses in years 3 and 4 (with or without a specialism at that stage).
