2.	Students must check the necessary pre-requisites before registering for optional LS or LX courses – please refer to the Course Catalogue online.
3.	The 5 credit point course LS 2531 may be taken in addition to the Legal Studies requirements in programme year 2. If this course is chosen the credit load for the year will be 125 credit points, of which 65 credits will be from Legal Studies courses.
4.	Language competency levels are listed as a guide, courses may vary based on ability and are subject to diagnostic testing.
5.	Candidates seeking entry to the Junior Honours programme must have accumulated, by award or recognition, or been exempted from, at least 240 credit points at levels 1 and 2, including the prescribed courses required to enter programme year 3.
6.	** Level 2 students opting to take the combination FR 2513/FR 2514 and FR 2510 should be aware the credit weighting will be 45 credits in the first half session and 75 credits in the second half session as opposed to the standard 60/60. This will result in a heavier workload in the second half session.
