PART TIME ROUTE

Duration: 24 months part-time (MSc); 18 months part-time (PgDip); 8 months part-time (PgCert).

Part time students will negotiate their programme of study with the Programme Leader. Students undertake a programme of study as agreed with the programme leader, taking 30 credit points per semester (90 credit points per year of study).
